Sub: Rules regarding refund of fees under withdrawal to newly admitted UG, PG and Ph.D. students at Mesra and its Extension Centres [except NRI/OCI/FN students]

It has been decided that refund of fees, received from a student who has taken admission in any program of the Institute and subsequently decides to withdraw from the program, will be made as per the following rules:

(A) For students admitted before commencement of classes:

4	Withdrawal after admission already being declared closed.	Only caution money	

(B) For students admitted after commencement of classes:

1	Withdrawal within seven working days after the date of admission provided there is a subsequent round of admission scheduled wherein the seat thus vacated may be filled up.	80% of fee deposited at the time of admission (rounded off to the next Rs.100/-)	
2	Withdrawal after seven working days from the date of admission	60% of fee deposited at the time of admission (rounded off to the next Rs.100/-)	
3	Withdrawal after admission already being declared closed.	Only caution money	

However, the student has to apply to get the refund giving specific reasons for withdrawing permanently from the programme and the payment will be made in due course of time.

This provision for refund of fees is valid only for freshly admitted students at Mesra and its Extension Centres pertaining to Academic Session 2023-24.

There is no extra processing charge if a candidate is upgraded from one Centre to another against the same admission process. In case of any other process, the candidate has to pay an additional amount of Rs. 10,000/- as a processing charge.
